### Changes to Council Tax discounts

In accordance with Section 11 (as amended) of the Local Government Finance Act 1992, the Council has amended discounts in respect of certain types of properties from 1 April 2013. These are shown below.

For unoccupied and unfurnished properties a 0% discount will apply.

For properties requiring /undergoing major structural work a 0% discount will apply.

For both above classes of property, an additional premium of 50% Council Tax will be charged from a date two years after the property first became empty.

For Holiday homes a 10% discount will apply.

For Second Homes a 0% discount will apply.
